- SUBJECT: Conduct of the 6<sup>th</sup> National Gender and Development Planning and Budgeting Fora (GAD Budget Fora) for National Government Agencies, Attached Offices, Bureaus, State Universities and **Colleges and Government-Owned and -Controlled Corporations**
- DATE: 23 October 2017
  - 1. The Philippine Commission on Women (PCW) in partnership with the Commission on Audit (COA) will conduct the 6<sup>th</sup> GAD Planning and Budgeting (GPB) Fora to clarify issues and concerns on the GPB process of national government agencies, attached offices, bureaus, State Universities and Colleges (SUCs) and Government-Owned-and-Controlled Corporations (GOCCs). It will be held on November 9 and 10, 2017 at the Sports and Cultural Center of the Commission on Audit (COA), Commonwealth Avenue, Quezon City. The provisional program has been attached as Annex Α.
  - 2. The 6<sup>th</sup> GAD Budget Fora aims to:
    - Reorient national line agencies, attached agencies, bureaus and 2.1. GOCCs on the Revised Guidelines on the Preparation of the Annual Gender and Development (GAD) Plans and Budgets and Accomplishment Reports including the supplemental guidelines on the procedure of GPB submission through the use of Gender Mainstreaming Monitoring System (GMMS):
    - 2.2. Clarify issues and concerns encountered by agencies in the preparation and implementation of their annual GAD Plans and Budgets; and
    - Present the guidelines in the audit of Gender and Development 2.3. (GAD) Funds and activities and common audit findings of government agencies.

- 3. **Two (2) representatives per agency** are invited to attend—preferably one (1) GFPS Member, and one (1) Budget Officer. Since the activity will be free of charge, confirmation will be on a first come, first served basis.
  - 3.1. Participating agencies should choose their preferred schedule—*either November 9 <u>or</u> November 10, 2017* and accomplish the online registration form at <u>bit.ly/GADBudgetFora2017</u> on or before November 3, 2017. Each participant will receive an electronic ticket with a unique barcode confirming their registration via email.
  - 3.2. The GAD Planning and Budgeting process of local government units (LGUs) and the guidelines governing the same are different, hence **LGUs are highly discouraged to attend;** and
  - 3.3. PCW will conduct a separate GPB Forum for Water Districts. Therefore, representatives from **Water Districts are also discouraged** to attend.
