Purpose

This Memorandum Circular is issued to provide a general guide for stakeholders on the national observance of the 2018 National Women's Month Celebration on March 1-31, 2018.

2. Background and Policy Mandates

The Philippine Commission on Women, in coordination with national government agencies and local government units, spearheads the National Women's Month Celebration.

The annual celebration is conducted to give due recognition to women's significant contributions in nation-building.

The following issuances serve as legal bases for the annual activity:

- Proclamation No. 224 s. 1988 Declaring the first week of March each year as Women's Week and March 8 as Women's Rights and International Peace Day;
- **Proclamation No. 227 s. 1988** Providing for the observance of the Month of March as Women's Role in History Month; and
- Republic Act (RA) 6949 s. 1990 Declaring March 8 of every year as National Women's Day.

3. Policy Content and Guidelines

3.1 Campaign Theme and Objectives

In 2017, the PCW Board Members and Inter-Agency Technical Working Group identified the NWMC theme "We Make Change Work for Women", which shall be used from 2017-2022. It highlights the empowerment of women as active contributors to and claimholders of development. This pursuit of development is also anchored on the government's commitment of "malasakit, pagbabago, at patuloy na pag-unlad".

Consistent with the theme and Proclamation No. 227 s. 1988, the annual conduct of the National Women's Month Celebration (NWMC) aims to give due recognition to the contributions of Filipino women in our society.

Specifically, 2018 celebration aims to:

Inform and engage women as stakeholders of government programs and services to promote citizen-centric governance and make "change" a conscious effort to know, understand, and provide what ALL citizens need;

Create and facilitate platforms to discuss good practices, gaps, challenges, and commitments in pursuing gender and development (GAD) to strengthen implementation of the Magna Carta of Women; and

Inspire and empower women and girls to be agents of change to contribute in promoting gender equality and the empowerment of all women.

3.2 Suggested Activities

In view of the above, government agencies and instrumentalities, non-government organizations, sectoral groups, private and civil society organizations at the national, regional and local levels, including local government units, are enjoined to conduct activities in line with this year's Women's Month Celebration theme and/or participate in the following activities:

3.2.1 Production of Information, Education and Communication (IEC) Materials

- Hanging of 2018 NWMC official streamer in all government agencies, including regional offices, local government units, and Philippine embassies and consulates; and
- Development, production and distribution of IEC materials for 2018 NWMC which include collaterals designed by PCW and agency-specific materials like flyers that feature agency services offered to their women clients.
- Wearing Purple T-shirts/blouses/polo every Thursdays of March (March 1, 8, 15 and 22) in support of #PurpleThursdays. Agencies are encouraged to either suspend implementation of their respective uniform policy on the said dates, or wear purple accessories or accents like button pins, scarves, wristbands, or ribbons with their uniform for the day.

3.2.2 Participation to Women's Month online advocacy

- Uploading of the official logo, advocacy video and other National Women's Month advocacy materials in government agencies' website, Facebook, Youtube and Twitter pages and using 2018 NWMC Facebook Camera Effects;
- Participating in the online campaign thread about the observance using the hashtag #WomenMakeChange;
- Featuring the organization's calendar of activities and activity implementation reports and Women's Month advocacy materials in their official websites, social media accounts and publications, and sending links to the reports to PCW through e-mail events.pcw@gmail.com; and
- Use the All-Women Cast Lupang Hinirang Video in agency's NWMC activities The music video can be downloaded at http://tiny.cc/allwomenlupanghinirang

3.2.3 Organizing or participation to Women's Month information campaigns/advocacy activities

We Make Change Work: Women Inspiring Women Forum

Modeled after TEDx format, this forum aims to celebrate women's journey and sharing inspiring stories of change in their chosen fields, to encourage their fellow women to be empowered change agents. It will also serve as a venue for women to inspire and appreciate each other, and create an environment supportive of each other. One of the identified activities for the 2018 NWMC is the conduct of Photo Contest and Poster-making Contest. Utilizing arts, particularly photography and poster making in promoting women's empowerment, the Contest targets young people as participants. The Contest will also contribute in the collection of photographs and artworks that depict the promotion of the rights and empowerment of all women and girls.

MECHANICS

Theme

Photos must capture the essential representation and role being played by Filipino women and girls as potent agents of positive change in our society.

Contest Duration

PCW will accept entries from March 1 to April 30, 2018.

Who Can Join?

- The contest is open to all college students enrolled in any schools in the Philippines (at the time they join the contest) nationwide. The PCW shall require all participants to submit a copy of their valid school ID or Registration Card as proof.
- Employees of PCW including their relatives up to second degree of affinity or consanguinity are not qualified to join the contest.

Submission of Entries

- Each participant shall be allowed to submit maximum of two (2) entries only.
- All entries must be submitted via email (<u>events.pcw@gmail.com</u>). Submissions made through other means will be automatically disqualified.
- Entries to be submitted should include the following details:
 - o Name
 - o Sex
 - Date of birth
 - Complete mailing address
 - Contact number
 - Name of school
 - Scanned copy or photo of valid school ID or Registration Card
 - Complete details of the photo including when and where it was taken and the camera/mobile device used
 - Photo caption

File name of photos should be patterned in this format: SURNAME_ENTRY NUMBER 1

Deadline of submission of entries is on April 30, 2018, 5:00 PM Philippine Standard Time.
 Entries received beyond the deadline shall automatically be disqualified.

Photo Image/Requirements

- Photos must be all original and full-colored. Black and white or sepia photos will be automatically disqualified.
- Photos must be in digital JPEG or JPG format, in high-resolution, 25MB maximum file size. (Recommended resolution: 3,000 pixels whether horizontal image or vertical image at 300 dpi.)
- Photos must not be digitally altered (colorizing, toning, collage, photo composites, stitched panorama, high dynamic range HDR images etc.) and/or enhanced in any way. Only simple cropping, minor adjustments in color, sharpness, contrast or digital equivalents are allowed.
- Watermarked photos and those that have been previously submitted or have won in any local or international photography contest will be disqualified.
- Photos to be submitted must be taken starting on March 1, 2018, the official launch of the photo contest.

OTHER CONDITIONS

By participating in the 2018 National Women's Month Photo Contest, the contestant attests that the submitted photograph is a single work of original material created and taken solely by the participant during the Contest period, and that no other party has any right, title, claim or interest in the photograph. PCW reserves the right to verify this through various means, and disqualify any photograph or image.

Submission of entries to the contest indicates full permission granted to PCW to use the photographs, with proper credit to the photographer in PCW IEC and other advocacy materials.

Short-listed entries and final winners agree to the disclosure and publication of their full names and entries in any photo, publicity or other media arrangement made by PCW related to the announcement of the results of the 2018 National Women's Month Photo Contest.

PCW reserves the right to cancel the contest at any time for any reason or whatsoever in its sole and absolute discretion without any obligation to furnish any reasons.

SELECTION OF WINNERS

PRE-SCREENING: Panel of judges from PCW will pre-screen all the submitted entries to ensure that the contestants have complied with the prescribed guidelines and it has no violent content, nudity or obscenity.

POSTING AND VALIDATION OF SHORT-LISTED ENTRIES: PCW will post all short-listed entries to its website and official Facebook account by May 31, 2018. PCW will accept feedback from interested parties from June 1 to 15, 2018. During this period, PCW will accept complaints of violation of the Contest Mechanics by any of the short-listed contestants, provided that supporting evidence/s are submitted.

FINAL DELIBERATION: Panel of judges from different organizations will then select ten (10) winners from the short listed entries. The decision of the judges is final and not appealable.

RECOMMENDED FILMS

Ang Kababaihan Ng Malolos

A musical docudrama film dramatizes the events from 1888 to 1906 when the Women of Malolos worked for the liberation of the country and of Filipino women. In 1888, the ladies asked the Governor General for permission to open a night school where they could learn Spanish. Despite the objections of the Spanish friars who saw this as a political move, the women opened their school in 1889, inspiring Jose Rizal to write his Letter to the Young Women of Malolos. But the school lasted for only four months because the Spanish friars cracked down on the town's activists. In 1896-1897, many of the women provided food, arms, and clothes for the Katipuneros of Bulacan. During the Phil-Am war in Feb 1899, eight of them served the first Red Cross in Malolos. In 1906, ten joined and recruited members for the local chapter of the Asociacion Feminista Filipina, the first women's organization in the country. The film ends with the firm resolve of Basilia's barcada to continue the struggle for the complete liberation of Filipino women of all classes.
