- 1. All passengers (Female) shall be allowed to avail of the free ride and enter or exit the station through the service gates from 7:00 am 9:00 am and from 5:00 pm 7:00 pm.
- Alighting passengers who have availed of the free ride may still be allowed to exit through the service gate or any assigned Automatic Gates up to the period between 9:01 am 9:35 am and 7:01 7:35 pm. Exiting beyond these time limits will subject the passenger to a penalty as LOST TICKET IN EXIT.
- 3. All passengers availing of the free ride shall be subject to the usual frisking and baggage inspection and shall adhere to all LRTA rules and regulations on behaviour inside LRTA trains and premises, most especially all its safety and security rules and regulations. All violators of the aforementioned rules shall be meted the applicable penalties.
- 4. The special boarding area is for the elderly, pregnant, and with disability, those who are availing the free ride should consider the above.
- 5. Strict compliance with the approved free ride schedule to avoid inconvenience.
